Please note:

- 1. Nominations will not be accepted on the day of Synod unless the number of nominations received is less than the required number of representatives.
- 2. The requirements of the Methodist Church's Safeguarding policy and SO 010 apply to District representatives to Conference - ie that 'no person who has been convicted of or has received a simple or conditional caution from the police concerning sexual offences against children shall be appointed to any office, post or responsibility or engaged under any contract to which this sub clause applies.'
- 3. SO 417 (2) In electing such representatives members of the Synod shall have regard for the composition of the membership of the District as a whole with regard to age, sex and ethnic origin.
 - (2A) All nominations made under clause 2 above shall be signed by at least two members of the Synod and shall include:
 - i. a proposer or seconder from the circuit in which the nominee is stationed or a member:
 - current appointments within the Church if any; ii.
 - age at the date fixed for the opening of the Representative Session of the iii. Conference in one of the following groups: under 25; 25-44; 45-64; 65 and over;
 - İ۷. ethnic origin
 - up to 25 words of relevant additional information and shall be made available to all members of the Synod then present before a ballot takes place.
